Payment must be made directly to QuestCDN. This cost includes access to online bidding. There will be no refunds. The QuestCDN project number is **9697041**. Bid quantities and schedules may be viewed prior to purchase under the "view bid documents" section on QuestCDN.

Each bid must be accompanied by a Bid Bond executed by a Surety Company in an amount not less than five (5) percent of the total bid made payable to the City of Blanding.

The Bidder must supply all the information required by the proposal forms and specifications and must bid on all items of every schedule. The City of Blanding reserves the right to waive any informality in, or to reject any or all portions of, the various bid items. No proposal may be withdrawn for a period of one hundred twenty (120) days from the opening thereof.

A non-mandatory virtual pre-bid meeting for all prospective bidders will be held via Microsoft Teams on May 28, 2025 at 2:00 p.m. (MDT).
