## **Parents Code of Conduct**

I hereby pledge to provide positive support, care, and encouragement for my child participating in youth sports by following this Parents Code of Conduct.

- I will encourage good sportsmanship by demonstrating positive support for all players, coaches, and officials at every game, practice or other youth sports events.
- I understand that to participate in any way (games as well as practices) it is required to be properly registered for each sport separately.
- I will place the emotional and physical well being of my child and other participants ahead of my personal desire to win.
- I will do my best to make sure that my child is at every practice, and if I'm not sure when it is, it is just as much my responsibility as the Coach's to find out when practice is.
- I will insist that my child play in a safe and healthy environment.
- I will support coaches and officials working with my child, in order to encourage a positive and enjoyable experience for all.
- I will demand a sports environment for my child that is free from drugs, tobacco, and alcohol and will refrain from their use at all youth sports events.
- I will remember that the game is for youth not adults.
- I will do my very best to make youth sports fun for my child.
- If I have concerns about coaches, officials etc. I agree to discuss with the coach or recreation director in an appropriate way and not in a disrespectful manner.
- I will ask my child to treat other players, coaches, fans and officials with respect regardless of race, sex, creed, or ability.
- I will help my child enjoy the youth sports experience by doing whatever I can, such as being a respectful fan, assisting with coaching, or providing transportation.
- I understand that if I don't live up to this Code of Conduct I will be asked to leave the premises/game. At the Recreation Directors discretion I may not be allowed back for the entire season or longer.
