



ORDINANCE 2025-6

AN ORDINANCE AMENDING THE BLANDING CITY CODE TO ALIGN WITH UTAH STATE CODE NOTICE REQUIREMENTS FOR REQUESTS FOR PROPOSALS (RFPs)

WHEREAS, the Blanding City Council finds it necessary to update the Blanding City Code regarding the noticing requirements for Requests for Proposals (RFPs) to align with the minimum standards required by Utah State Code § 63G-6a-112; and

WHEREAS, the current Blanding City Code imposes additional noticing requirements that exceed those prescribed by the Utah State Code for RFPs; and

WHEREAS, the City Council believes that aligning local practices with the minimum state requirements will streamline the procurement process and ensure compliance with state law;

WHEREAS, Blanding City would still attempt to publicize RFPs in the local newspaper when timelines line up, but are not required to do so.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BLANDING, UTAH, as follows:

Section 1. Amendment to Section 1.11.1(B)(3)(c). of the Blanding City Code

The Blanding City Code is hereby amended to revise the noticing requirements for Requests for Proposals (RFPs), to reflect only the minimum requirements set forth in Utah State Code § 63G-6a-112. The updated section shall read as shown below.

Public notice of the invitation for bids shall be given a reasonable time prior to the date set forth therein for the opening of bids, but at least 7 days before the response deadline. The notice shall include publication on the main website for the procurement unit, or in the local newspaper, or on the state procurement website. There can also be a combination of the aforementioned avenues for publication in a newspaper of general circulation a reasonable time prior to bid opening.

Section 2. Severability

If any part or provision of this Ordinance is held to be invalid, illegal, or unenforceable, such invalidity, illegality, or unenforceability shall not affect the validity, legality, or enforceability of the remaining provisions of this Ordinance.

Section 3. Effective Date

This Ordinance shall take effect immediately upon passage and publication as required by law.
