
An Ordinance regulating the Distance from the sidewalk at which Corrals and other enclosures for keeping animals may be built was also passed unanimously.

"AN ORDINANCE RELATING TO THE REGISTRATION OF DOGS; PROVIDING FOR A LICENSE AND FOR THE IMPOUNDING AND KILLING OF DOGS IN CERTAIN CASES."

BE IT ORDAINED by the Town Board of the Town of Blanding, San Juan County, Utah:

Section 1. It shall be unlawful for any person to keep within the limits of this town, without making application to the Treasurer for that purpose, and paying to said treasurer for the benefit of said town an annual tax of five dollars for a female dog and two dollars for a male dog. It shall be the duty of the treasurer to register the applicant's name and a description of the dog, and to give to said applicant a certificate of registry.

Section 2. It shall be the duty of the owners of dogs so registered to provide the same with suitable collars and with a metallic plate or tag attached thereto having a number corresponding with the certificate of registry inscribed thereon. All dogs not so registered and collared, as aforesaid, found running at large shall be impounded.

Section 3. Any dog impounded as an unlicensed dog may be redeemed by the owner or any authorized person upon exhibiting to the person having charge of said pound a certificate of registry as provided in Section 1, showing that the license in such section imposed has been paid for such dog, and upon paying the person in charge of said pound an impounding fee of one dollar and the sum of 25 cents for each and every day such dog shall have been impounded. All impounded dogs not redeemed within five days shall be killed by the person having charge of said pound.

Section 4. It shall be unlawful for the owner of any female dog to permit it to run at large while in heat, and such dog so running at large may be killed by the town marshal.

Section 5. Any person violating any of the provisions of this ordinance shall, upon conviction therefor, be punished by a fine in any sum not exceeding \$50.00.

Passed by the President and Board of Trustees of the Town of Blanding, San Juan County, Utah, June 7, 1920.







An Ordinance granting a franchise to The Midland Telephone Company, its successors and assigns, to construct, maintain and operate telephone and telegraph lines in the Town of Blanding, Utah.

THE BOARD OF TRUSTEES OF THE TOWN OF BLANDING, UTAH, DO ORDAIN AS FOLLOWS:

Section 1. That permission and authority are hereby granted to The Midland Telephone Company, a Colorado corporation licensed to do business in the State of Utah, its successors and assigns, to construct, maintain and operate telephone and telegraph lines in the Town of Blanding, to erect the necessary poles, conduits or other structures, along or across the streets, alleys and other public places in the town of Blanding, subject to the supervision and satisfaction of the street supervisor of said town, that the grantee hereunder shall have the right to maintain and operate such lines in the corporate limits of said town for a period of twenty years.

Section 2. That the rates charged for telephone service shall not exceed the rates charged for like service in any town of like condition in the State of Utah, and shall be the rates prescribed by the Public Utilities Commission of Utah.

Section 3. That the grantee hereunder shall extend such service to any and all parts of the town as necessity demands, provided that any extension over 200m feet in length shall be made at the expense of the subscriber.

Section 4. Said grantee for the year of 1927 and for each and every year thereafter during life of said franchise pay into the the treasury of the town of Blanding, for the use of said town corporation, an annual license tax of ten dollars, and in further consideration of the granting of said franchise the said grantee shall pay all the costs of publication of this ordinance.

Section 5. This ordinance shall be in effect fifteen days after its publication.

POWER PLANT

TOWN OF BLANDING, UTAH

Bids will be received by the Town Clerk of the Town of Blanding Utah up to 8 P.M. o'clock Oct. 31st 1928 for the furnishing and installation complete of a Diesel Electric Power Unit. This power unit is for generating electrical energy for general light and power service and for street lighting, and must be capable of furnishing approximately 31 Kilowatts at the Switchboard, taking into consideration the location of Blanding above sea level. The machinery shall be complete in every detail and turned over to the Town in readiness to operate. The Town will extend its transmission lines into the power House, ready for connection to the switchboard.

POWER UNIT SPECIFICATIONS

ENGINE:

Engine must be a heavy duty, slow-speed, airless injection, Full Diesel Type, capable of developing not less than 60 brake horsepower based on sea level rating. Engine to be of the special electric type, fitted with heavy flywheel and with extended shaft and outboard bearings

AUXILIARY FUEL TANK:

Auxiliary Fuel Tank of not less than 700 gallons which shall be buried outside the power house and fitted with proper pipe and fittings to connect to engine fuel pump.

EXHAUST:

The exhaust from engine shall be carried thru cast iron exhaust pipe to concrete exhaust pit, to be located in floor of power house. The concrete exhaust pit shall extend beyond the outer wall of the power house and necessary exhaust stack not less than 12" in. diameter 20' ft. long shall be furnished by the successful bidder and installed together with stack thimble. The exhaust stack shall be of welded steel pipe of proper weight. This is to be used to carry exhaust gasses from pit to atmosphere. Concrete exhaust pit mentioned to be furnished by Town. All work and equipment in this connection shall be in conformity with special laws and provisions as established by the Town of Blanding and the State of Utah.

STATION TRANSFORMER:

Bidder shall furnish suitable transformer for installation in power house, to properly take care of auxiliary motor load in power house lighting.

FOUNDATIONS:

Bidder shall furnish detailed foundation plans for all equipment he proposes to furnish. The Town will provide necessary foundations for all equipment.

DELIVERY:

Bidder shall state approximate time of delivery at Blanding, Utah, also approximate time for installation after equipment reaches Blanding.

FUEL AND LUBRICATING OIL GUARANTEES:

Bidders are required to give fuel and lubricating oil guarantees, based on full load, three quarters load and half load operation of engine and must state the grades of oil on which their engines will successfully operate. Bidders shall furnish a list giving names and locations of not less than ten municipalities now using Diesel Engine generating equipment of their manufacture, which may be used as reference plants by the Town of Blanding.

FREIGHT:

Bidders must take care of the freight charges from factories to nearest railroad point to Blanding, also all drayage and cartage charges from railroad point to power site.

INSTALLATION:

Bidders must install equipment complete on foundations furnished by the Town. Equipment must be complete in every detail, and to be turned over to the Town in operating condition, delivering power to the switchboard. Bidder must furnish as mentioned before all necessary pipe, valves and fittings for air, water, fuel and lubricating oil, and completely install this equipment.

FOUNDATION BOLTS: Bidders must furnish necessary foundation bolts for all equipment they propose to install.

BONDS:

Bidders shall furnish a certified check for not less than 5% of the amount of their bid, or bidders bond in a company acceptable to the Town of Blanding. The successful bidder shall be required to furnish a bond acceptable to the Town of Blanding for the faithful performance of the contract.

TERMS OF PAYMENT:

Terms of payment shall be: 25% of contract price with acceptance of bid by the Town, 25% on delivery of equipment at Blanding, 25% on completion of installation and balance 30 days after completion of installation.

WHEREAS, by the result of a special election duly called and held in the Town of Blanding, Utah, on the 31st day of October, A.D., 1928, said Town was authorized and empowered to issue and sell Fifteen Thousand Dollars (\$15,000.00) Light Bonds for the purpose of paying the cost of constructing and installing a lighting system and works to supply said Town and the inhabitants thereof with artificial light, and,




